I was previously a clinical tutor and seminar leader at the United Medical and Dental School of Guys and St Thomas' Hospital, and was a GP Trainer from 1991 - 2013. From 1992 to 2002 I was the Course Organiser for the Lewisham General Practice Vocational Training Scheme. I taught on various courses for the London Deanery including: the GP Trainee Summer School 1992 – 1995, Practice Management Module GP Trainers Course, 1994, GP Trainer preparation module "Towards Training", 1998, 1999, 2000, 2002, and the generic initial educational module, "Foundations", 1999. I taught Philosophy and Ethics for the Society of Apothecaries and was awarded the 2004 Thomas Sydenham Medal from the Society. I was President of the Faculty of the History and Philosophy of Medicine of the Society of Apothecaries from 2011 – 2014 and was awarded an Honorary Fellowship of the Faculty in 2016. I was Course Director of the Diploma in the Philosophy of Medicine of the Society of Apothecaries and remain an Examiner for the Diploma.

#### **Current Research and Scholarly Activities:**

My interest is in the Philosophy of Medicine and Medical Ethics. I also chaired the Academic Writing Award panel of the Society of Medical Writers.
