## 1 PURPOSE

This policy outlines the university process regarding students' general health, infectious diseases screening and vaccinations. RCSI Bahrain is aware of its overriding duty of care to the public with whom students are in close contact, and takes reasonable and appropriate measures not only to safeguard students but also patients and members of the public.

## 2 POLICY STATEMENT

All medical and nursing students must read and agree to abide by the terms and conditions of the Kingdom of Bahrain Ministry of Health (MOH) Policy - "***Policy for Immunization and Infectious Diseases Screening for Medical, Dental, Nursing, and Physiotherapy Students***" and the RCSI Bahrain policy on Blood Borne Viruses.

The Student Health and Wellbeing Unit of the Student Development & Wellbeing Department at RCSI Bahrain is responsible for ensuring that students' medical records, screening and vaccinations are compliant with the Ministry of Health regulations.

## 3 APPLICATION

This policy is applicable to all RCSI Bahrain students.

## 4 POLICY CONTENT

### a. Covid-19

Students with conditions like lung or heart disease, diabetes or conditions that affect their immune system are at higher risk for Covid-19 illness and complications. Students with conditions which make them more vulnerable to Covid-19 should inform the Student Health and Wellbeing Unit [student-health@rcsi-mub.com](mailto:student-health@rcsi-mub.com)

#### **Covid-19 vaccination**

**All students must be vaccinated against Covid-19.** This is a requirement of the teaching hospitals and clinical sites. Students should contact [student-health@rcsi-mub.com](mailto:student-health@rcsi-mub.com) for any queries and concerns about vaccination. The Covid-19 vaccine is available from the Ministry of Health free of charge to all residents of Bahrain, including international students who hold a CPR national identity card. Students can register for the vaccine on the BeAware Bahrain app or on the Health Alert website: <https://healthalert.gov.bh/en/>

### b. General Health

Applicants to the university **must** disclose a known disability or medical condition. The Student Health and Wellbeing Unit can discuss health and wellbeing support available under the university's Reasonable Accommodation Policy. **RCSI reserves the right to discontinue students who have failed to disclose significant health information which may, even with the provision of Reasonable Accommodation, prevent a student from progressing through the academic programme.** Where necessary, the assessment of a candidate's ability to progress through the programme will be made by referral to an independent Occupational Health Consultant and following the university's Fitness to Study policy. ***Students have a responsibility to protect the interests of the public and their colleagues and to inform RCSI if any form of physical, mental or other ill-health could seriously affect competence and responsibility to patients.***

**Students have a responsibility to self-care, both for their own benefit and for that of colleagues and the public with whom they will come in contact.** This responsibility takes many forms, but one obvious one is for students to provide clinicians who will be involved in their care in Bahrain with adequate advance information on any significant ongoing health issue.

Some examples of what might be needed include:

- **Diabetes:** List of current medications and blood results over the previous year
- **Asthma:** List of current medications and copy of previous spirometry
- **Ongoing surgical issues:** Relevant copies of specialist reports and investigations
- **Psychiatric illness:** Relevant reports from specialist and current treatment plan
- **ADD/ADHD (attention Deficit Disorder/attention Deficit Hyperactivity Disorder):** These conditions require some special attention as there are several difficulties in having these diagnoses made and treated in Bahrain.
- **Gastroenterological issues:** Relevant copies of specialist reports and investigations, particularly endoscopies.

This list is not exhaustive, but is meant to facilitate continuity of good quality medical care. All reports should be in English.

## **b. Needle stick injuries**

Students must report any needle stick injury to the appropriate clinical authority at their clinical placement. The clinical authority is responsible for assessing the risk and providing first aid treatment and follow up, which may include booster vaccinations and blood borne virus testing. The student must also inform the Student Health and Wellbeing Unit staff, who will provide counselling and advice to the student for follow up at the student's local health centre. A copy of the incident report and serology screening will be kept in the student's confidential health file in the Student Health & Wellbeing Unit. The Student Health & Wellbeing Unit maintains a database of needle stick injuries to monitor practice and identify retraining needs which may need to be communicated to the relevant School.

## **c. Infectious diseases medical screening and vaccination programme**

(i) Please also read the RCSI Bahrain Blood Borne Virus Policy.

Healthcare workers, including students, face the possibility of exposure to infectious diseases such as Hepatitis B and TB. While the risks are small, increasing efficiency of preventive measures such as vaccination has highlighted the importance of these diseases. RCSI has introduced procedures to offer both students and patients' protection against Hepatitis B, Tuberculosis and several other common diseases. According to the Ministry of Health regulations, RCSI students must be screened for and offered protection against the following diseases:

Hepatitis B and Hepatitis C

HIV

TB

Varicella/Zoster

Measles, Mumps, Rubella

Meningitis C

Tdap

Polio

Influenza

Covid -19

- **Hepatitis B**

1. First year students must attend for blood tests (Hepatitis B Surface Antigen, Hepatitis B Core Antibody) and medical screening according to the RCSI Bahrain Blood Borne Virus policy.
2. Non-immune students are required to be vaccinated against Hepatitis B through the programme organized by the RCSI Bahrain Student Health and Wellbeing Unit.
3. Students who show evidence of Hepatitis B or other serious infectious diseases are referred to the RCSI document Blood Borne Viruses Policy.

5. **The most time-consuming element of the screening and vaccination programme is vaccination against Hepatitis B which comprises of 3 shots over a six month period with a follow up blood test two months later to confirm seroconversion. Up to 10% of students will be negative at this point and will need to have the entire course again.** This obviously has implications for starting clinical attachments, doing electives etc., and is another reason to start the programme as early as possible.

- **Hepatitis C**

All students will be screened for Hepatitis C in first year and again prior to their clinical attachments.

- **Measles, Mumps and Rubella**

1. Students must provide evidence of having received two doses of MMR.
2. Students who cannot provide evidence of having received both doses of MMR must receive a booster dose of MMR.
3. Students without any prior vaccination should receive both doses of MMR, given at least one month apart, unless otherwise contra-indicated.

- **Pertussis (whooping cough)**

1. A booster dose of a low-dose pertussis containing vaccine (Tdap-Boostrix) is now (2013) recommended for health care workers, including students, who come into contact with infants, pregnant women and the immunocompromised to prevent transmission of this disease.

- **Chicken pox (Varicella)**

1. Students without a definite history of chickenpox or vaccination will be considered non-immune, and will be tested for the presence of immunity to Varicella Zoster Virus.
2. Non-immune students may need vaccination against VZV.  
It is important that a copy of the post-vaccination blood test confirming immunity is given to the Occupational Health Officer. If a student comes into contact with chicken pox and cannot demonstrate immunity, they will be removed from clinical duties and patient contact for 21 days. Also, students may wish to participate in overseas elective attachments and many of these insist on evidence of immunity to Varicella. More information is available here:

- **Polio**

Students are required to provide documentation of a complete primary series of polio vaccine. A complete series consists of 5 doses for children up to 6 years of age, and 3 doses after age 7

- **Influenza Vaccine**

Students are encouraged to receive the annual influenza vaccine. The vaccination will be made available to students at King Hamad University Hospital free of charge between the months of October until March each year.

- **Covid-19 Vaccine**

All students must be vaccinated against Covid-19 and evidence of vaccination must be submitted to [student-health@rcsi-mub.com](mailto:student-health@rcsi-mub.com). Students attending clinical placements cannot attend without proof of vaccination. Any boosters required must be taken in accordance with the requirements of the Ministry of Health. The Covid-19 vaccine is available from the Ministry of Health free of charge to all residents of Bahrain, including international students who hold a CPR national identity card. Students can register for the vaccine on the BeAware Bahrain app or on the Health Alert website: <https://healthalert.gov.bh/en/>

- **Tuberculosis**

Students will be assessed in relation to Tuberculosis as part of the pre-registration screening. Medical students will be assessed again prior to entering clinical placement during Year 3 (IC2/3).

- **Mantoux Testing**

Regardless of previous BCG vaccination, all students will need to provide evidence of having a Mantoux test during pre-registration screening. Medical students will be assessed again prior to commencing clinical placement during Year 3 (IC2/3).

*Results of Mantoux:*

- **Less than or equal to 5mm and unvaccinated** - will receive TB education
- **Greater than 5mm but less than 15mm** - will receive TB education.
- **Greater than or equal to 15mm** – refer for medical evaluation.

*Medical Referrals*

Students with a positive PPD greater than 15mm will need to seek medical evaluation and treatment from a health care provider, a medical report detailing the investigations and treatment plan should be given to the Student Health Service and the report will be kept in the student health records. Students will need to pay for Tb follow up investigations and treatment.

- **Meningitis C**

1. Students should provide evidence of receiving one dose of Meningitis C vaccine.
2. Otherwise, students will be offered vaccination (a single shot).

- **HIV**

All students must undergo HIV screening as part of the pre-registration screening. International students may also require rescreening on arrival in Bahrain (see i. below). Medical students will be screened again prior to commencing clinical placement during Year 3 (IC2/3).

**By participating in the above medical screening and vaccination programme, students agree to comply with the following :**

- Take appropriate tests and clinical follow-up for Hepatitis B, Hepatitis C and HIV
- Vaccinate for Hepatitis B and undergo follow-up testing, if deemed necessary
- Screening for Tuberculosis, if necessary
- Screening for immunity to measles, mumps, rubella and chicken-pox and subsequent vaccination, if necessary
- Follow the vaccination programme for healthcare workers stipulated by the Ministry of Health, Bahrain.
- Provide RCSI Bahrain with proof of medical screening and vaccination records, as necessary
- Positive participation in immunization campaigns such as Covid-19 and influenza vaccination programmes.

Complex work is required in the gathering of individual assessments, documentation of vaccinations, blood tests to confirm current immune status for different diseases, administration of vaccination programmes (unique to each individual), and appropriate screening and follow up. This work is carried out by the Student Health and Wellbeing Unit, in conjunction with specified medical services providers.

Many elective hospitals and prospective employers seek confirmation of a student's immunisation status. If this is not completed and supplied to them, students will not be granted such elective or job. The bulk of this work should be completed in first year. Subsequent clinical years will require some further appointments (e.g. rescreening for Hepatitis B, C and HIV prior to commencing clinical placement in Year 3 (IC2/3) for medical students, annual influenza vaccinations and Covid-19 booster vaccinations as required for all medicine and nursing students in clinical placements).

**It is very important that students attend for vaccination/screening appointments when requested.** Students will be excused from lectures to attend these appointments.

**Non-compliance with the medical screening and vaccination programme is a breach of the RCSI Bahrain Code of Conduct and can result in discontinuation from the university.**

**(ii) Pregnancy**

Most of these vaccines are contra-indicated in pregnancy. It is extremely important that students do not proceed with vaccinations if they are, or may become, pregnant over the course of an immunization programme. Students should discuss their case in confidence with the Occupational Health Officer in the Student Health and Wellbeing Unit [student-health@rcsi-mub.com](mailto:student-health@rcsi-mub.com)

**(iii) Screening and Vaccination Programme: Costs**

**First Year** (all newly registered RCSI Bahrain students)

- Students are expected to have all required medical screening and vaccinations completed prior to joining the university (pre-registration screening).
- Students who are holding Bahraini passports and who have completed their screening at a health centre in Bahrain **will not** need to have **repeat screening** after registration.

- Students who are holding a passport from a Gulf Cooperation (GCC) country who have completed their initial medical screening at a Ministry of Health facility in that country **will not** need to have repeat screening after registration.
- Students who are residents of certain Gulf Cooperation (GCC) countries who have completed their initial medical screening at a Ministry of Health facility in that country, which is accepted by the Kingdom of Bahrain Ministry of Health, **may not** need to have repeat screening after registration. The Student Health and Wellbeing Unit will advise if repeat screening is required.
- All other students **must have** repeat medical screening after registration. The Student Health and Wellbeing Unit will make the necessary arrangements for the screening and inform the student accordingly. There is a cost for this screening, which will be communicated to students upon registration. Students are responsible for paying their medical screening fees directly to the clinic providing the screening. Results are provided to the Student Health and Wellbeing Unit for follow up as necessary (see RCSI Bahrain Blood Borne Virus Policy).

### **Other Years**

Vaccinations which require updating will be provided by RCSI Bahrain at King Hamad University Hospital, free of charge. Any further serology tests or medical screening required (i.e. School of Medicine Year 3) will be paid for by the student.

#### **(iv) Elective Applications**

Students who require elective application forms to be completed should request an appointment with the Occupational Health Officer [student-health@rcsi-mub.com](mailto:student-health@rcsi-mub.com). If additional blood tests are required, there will be a charge for the tests. Vaccinations are free of charge.

### **d. Outbreak Situations**

1. In the event of an outbreak of any infectious illness on campus, in clinical locations or in the wider local community, students are required to adhere to all infection control measures recommended during that outbreak.
2. Students who contract an infectious illness should adhere strictly to the Ministry of Health and clinical location guidelines, they must adhere to isolation recommended and must not return to campus or clinical environment until that period has elapsed and they have recovered from their illness. Advice can be obtained in confidence from the Occupational Health Officer [student-health@rcsi-mub.com](mailto:student-health@rcsi-mub.com)
3. Students should avail of any other appropriate immunization as and when recommended during an outbreak situation. This may include obtaining boosters to previously completed primary immunization courses.

### **e. Summary of Process**

#### **i) Initial screening and vaccinations prior to registration**

1. The Admissions Department will send the Student Agreement together with a copy of this policy, the Blood Borne Virus Policy and the Ministry of Health Policy referred to in this document to accepted student applicants for review and signature of acceptance.
2. Prior to registration in the university, all accepted student applicants must complete an initial blood borne viruses screening. Screening results and immunizations records are sent by the student to the RCSI Bahrain Student Health & Wellbeing Unit, which confidentially

maintains student health records. Infectious Disease screening results are only valid for a period of three months, therefore **screening should not be done more than three months before the start of the programme**, as results will no longer be valid and cannot not be accepted.

3. If the screening result submitted is positive for an infectious disease, the student is not be eligible to join the program according to the Kingdom of Bahrain Ministry of Health regulations.

#### **ii) Student rescreening after registration**

- Students who are holding Bahraini passports who have completed their screening at a health centre in Bahrain **will not** need to have **repeat screening** after registration.
- Students who are holding a passport from a Gulf Cooperation (GCC) country who have completed their initial medical screening at a Ministry of Health facility in that country will **not** need to have repeat screening after registration.
- Students who are residents of certain Gulf Cooperation (GCC) countries who have completed their initial medical screening at a Ministry of Health facility in that country, which is accepted by the Kingdom of Bahrain Ministry of Health, **may not** need to have repeat screening after registration. The Student Health and Wellbeing Unit will advise if repeat screening is required.
- All other students **will need to have** repeat medical screening after registration. The Student Health and Wellbeing Unit will make the necessary arrangements for the screening and inform the student accordingly. Repeat medical screening will take place during the first six weeks of the academic semester. Information on rescreening is given to students during their orientation programme into the university by the Student Health & Wellbeing Unit.

Offers of places in the School of Medicine and School of Nursing and Midwifery are made to students in good faith and are subject to the results of the repeat medical screenings. If a student is subsequently found to be tested positive for a blood borne virus, the offer will be considered null and all fees paid will be reimbursed. The student will have to be repatriated according to the Kingdom of Bahrain Ministry of Health regulations.

#### **iii) Student medical screening and vaccination records**

1. Student screening results are retained confidentially in the Student Health and Wellbeing Unit and in the student record file in Student Records (SARA), according to regulations of the Higher Education Council.
2. Medical screening and vaccination records will be maintained for each student by the Student Health & Wellbeing Unit. This information is strictly confidential and only accessed by the relevant personnel.
3. Students can have access to their medical reports and immunization record on request from the Student Health and Wellbeing Unit, for example when students are applying for electives. Vaccination records are returned to students upon graduation. Student medical records will be retained in accordance with the university policy on data retention, and following data protection regulations of the Kingdom of Bahrain.

#### **iv) Vaccinations and rescreening during the academic programme**

**Vaccinations**: During the academic programme, the Student Health & Wellbeing Unit is responsible for ensuring that students' vaccinations are up to date. Vaccinations are offered to all RCSI Bahrain students, free of charge, at King Hamad University Hospital, through the Staff Health Clinic. The Covid-19 vaccine is available from the Ministry of Health free of charge to all residents of Bahrain, including international students who hold a CPR national identity card.

According to the Ministry of Health Policy (page 5: Strategies to minimize infectious disease risks), students can only opt out of the immunization programme with the prior written approval of the Vice President of Academic Affairs, for example in case of previous adverse reactions and immuno-suppressed students. In such cases, the Occupational Health Officer would arrange a risk assessment of the student and discuss the case with the Vice President of Academic Affairs.

v) **Rescreening**

All School of Medicine students will be rescreened for Hepatitis B, Hepatitis C, HIV and Tuberculosis in Year 3 (Intermediate Cycle 2). This is **mandatory**. Students' vaccinations will also be updated. If results for a blood borne virus are positive, the student will not be eligible to continue on the programme according to the Kingdom of Bahrain Ministry of Health regulations. The university is required to inform the Disease Control Section at the Ministry of Health of the positive results.

vi) **Blood borne virus testing : Positive results**

If a student tests positive for a blood borne virus at any stage during his/her programme of study, the Student Health and Wellbeing Unit is required to immediately notify the Disease Control Section at the Ministry of Health. Hepatitis B, Hepatitis C and HIV are notifiable diseases according to the Ministry of Health regulations. This notification process is standardised and requires the provision of demographic details so that the public health authorities can undertake contact tracing if indicated, in order to ensure public safety.

The student will be asked to meet confidentially with an appropriately qualified physician and a member of the Student Health & Wellbeing Unit so that he/she can be provided with post-test counselling and psychological support, and discuss treatment options.

## 5 Frequently Asked Questions

**Where can I get a copy of the Infectious Disease Screening and Immunization Form?**

**What should I do if my physician doesn't speak English?**

You will need to have the information needed for the form and all your relevant records translated into English.

**Can I scan my immunization records and send them attached to an e-mail?**

New students should submit their records to the Link provided ( see appendix 1). Enrolled students can send immunization reports to [student-health@rcsi-mub.com](mailto:student-health@rcsi-mub.com)

**Do I have to pay for my screening required immunizations, or are they covered by RCSI?**

Vaccinations are free of charge, however blood tests (serology testing) should be paid by the student.

**What immunisations are necessary?**

Please refer to the main document above for a complete list and instructions. You will find specific requirements for measles, mumps, rubella, hepatitis B, meningococcal disease, Influenza and Covid-19 vaccination, as well as a recommendation for varicella (chicken pox).

**What should I do if my immunisation records are lost or unavailable?**

You could have special blood tests called IgG titers to show immunity. You will be offered vaccinations against those diseases to which you are not already immune.

**Why do I need to have two mumps vaccines?**

It is strongly recommended that students entering medical university have proof of two doses of a mumps vaccine or MMR (measles, mumps, and rubella) or proof of immunity through blood testing. This is also recommended as a way to decrease the risk of mumps among the students and others in the community in which they reside.

**In my country, a rubella immunisation is required for females only.**

Rubella immunity is required for all male and female students. Regardless of your sex, you must have a rubella immunisation or a blood titre that proves immunity.

**Will you accept my mother's word that I was immunised for measles, mumps, and rubella?**

While your parents may be a reliable source of knowledge about your childhood health, we do require medically documented proof of immunity. Blood titres can also be used to prove immunity.

**What does "documented proof" of immunity mean?**

Documented proof is a written record of your immunisation dates provided by school, university, college, or physician's office, and/or results of laboratory blood testing.

**My blood titre was equivocal or borderline. Do I need another immunisation?**

Yes, because we cannot accept borderline immunity. You will need another immunisation to boost your immunity.

**Do I need the hepatitis B immunisation if I'm married?**

Yes. The hepatitis B immunisation is required by law for all newly entering students, regardless of age, gender, or marital status.

**Do I need the Covid-19 Vaccine?**

Yes. All students must provide proof of being fully vaccinated against Covid-19. Covid-19 vaccination will be mandatory for student to attend clinical locations and is mandatory for entry to many social environments such as cinemas, indoor dining.

**How many shots are there for the hepatitis B immunisation?**

Three. The second injection must be administered at least 28 to 60 days after the first injection. The third injection must be administered six months after the first injection.

#### **RCSI Bahrain Student Health & Wellbeing Unit** **New Applicants Immunizations and Infectious Disease Screening Form**

In compliance with the Ministry of Health, “***Policy for Immunization and Infectious Diseases Screening for Medical, Dental, Nursing, and Physiotherapy Students***” (Policy attached) all new applicants must submit evidence of having completed the Infectious Disease Screening identified below (Section A) and complete the Immunization Report (Appendix 1). **Please note that all new students will need to provide proof of completing the Covid-19 Vaccine.**

#### **International Applicants**

Should complete the screening identified below (Section A) and get (Appendix 1) completed by their health care provider. It is mandatory that international applicants who require rescreening are re-screened for Infectious Diseases once they arrive in Bahrain. The Student Health & Wellbeing Unit will advise of the requirement for rescreening and arrange this following registration.

#### **Applicants from the GCC**

Should complete their Infectious Disease Screening identified below (Section A) at a Ministry of Health Facility in their country of origin. **Results should be recorded on a medical examination certificate, which clearly states the applicant’s fitness and stamped by the health authority.** Their health care provider should complete Appendix 1.

#### **Bahraini Applicants**

Bahraini applicants should complete their Infectious Disease Screening at their Local Health Centre and results should be recorded on the “Medical Examination Certificate – Studies Fitness”. Their health care provider should also complete Appendix 1 at the local health centre.

### **Section A. Infectious Disease Screening Required:**

- Hepatitis B Surface Antigen
- Hepatitis B Antibodies
- Hepatitis C Antibody
- HIV 1 & 2
- Tuberculosis Screening (PPD skin test)
- Chest X Ray

The Infectious Disease Screening and immunization report should be submitted to [link](#) by **31 August 2021**. **Please note: Infectious Disease Screening completed more than 3 months from registration will not be accepted.**

Applicants should complete the required vaccinations listed in (Appendix 1) before registration. Once enrolled in RCSI Bahrain, Student Health & Wellbeing Unit will arrange for vaccines to be updated accordingly.
