# THE DEAN'S MEDAL





# EXECUTIVE DIRECTOR'S REVIEW

I am delighted to present the Faculty's 2018/2019 Annual Report.

Following on from the Deans' review, I would like to begin by expressing my sincere gratitude to Dr Theresa Frawley, Dean, and the Board of the Faculty of Nursing and Midwifery, for their unwavering support of the Executive. As highlighted by the Dean, the Faculty continues to evolve and create opportunities to develop the Faculty and its activities to ensure its long-term sustainability.

#### Governance

The establishment of the Governance Sub-Committee under the auspices of the Board of the Faculty of Nursing and Midwifery has completed a review of Standing Orders, developed a Code of Corporate Governance and other supporting documentation, contributing to good governance processes.

#### Strategy

The Faculty conducted an evaluation of its existing strategic plan (2014-2019) and a PESTLE analysis was completed to inform the new strategic plan (2019-2022). The Faculty has structured its new strategic plan and framed it based on the wider college plan. The Faculty prides itself on ensuring

this strategic link to operational endeavour within the governance framework of the Faculty Board, RCSI Senior Management and the Surgery and Post Graduate Faculties Board. The Faculty continues to work in a values based approach to meet the needs of practitioners and enhance service need in a rapidly evolving healthcare context.

# **Human Resources**

The Faculty bid farewell to Ms Maria Fox, Faculty Administrator and welcomed Ms Áine Halligan. We thank Maria for her hard work and dedication and wish her well. The Faculty also appointed Dr Cathy Fitzgerald as a Post-Doctoral Research Fellow who is leading out on the development of our European Centre of Excellence with partners from over 20 countries. The Faculty also welcomed the appointment of Dr Edward Naessens, as Programme Coordinator, to scope a project to review the pedagogy and platforms for CPD delivery.

#### **Operations**

The RCSI Aptitude Test for Overseas Nurses continues to facilitate nurses from overseas with an alternative to the current adaptation/assessment model for assessing the competence of nurses and midwives.

Approximately 800 nurses undertake this assessment annually, supporting responsive and timely recruitment into the Irish healthcare workforce. The test successfully completed a quality review by the RCSI Quality Enhancement Office. This year the Faculty was invited by the HSE HR department to scope the development of the Aptitude Test for nurses wishing to register and practice as psychiatric/mental health nurses.

The Faculty would like to acknowledge the leadership and professionalism of Dr Maria Neary, Aptitude Test Coordinator and Ms Pamela Peppard, Administrator, in the management and coordination of this very significant work. In particular, the Faculty acknowledge the RCSI IT Department, Moodle colleagues and the two hundred OCSE Assessors who are critical to the successful delivery and provision of the Test. I wish to also acknowledge the support of Ms Lasarina Maguire, Board Member, who acts as a "super assessor" supporting the continuous quality improvement of the test.

The Faculty's Continuing Professional Development (CPD) collaborations have continued to expand with the development of innovative, clinically relevant CPD

programmes for partnerships with the Irish Medical and Surgical Trade Association (IMSTA), the Psychiatric Nurses Association of Ireland (PNA), SIPTU's Health Division and the Dublin Simon Community. Other important initiatives during the last year include the further development of the Faculty's ePortfolio supporting online application for Fellowship by Examination with our Partners Axia Digital Ireland. In partnership with Axia, the Faculty has also submitted two proposals that expand the use of the ePortfolio at undergraduate and graduate level. The Faculty would like to thank Ms Catherine Clune Mulvaney, Operations and Education Manager and Ms Áine Halligan, Faculty Administrator for their skilful management of these programmes.

The Faculty in collaboration with the School of Nursing and Midwifery RCSI are scoping the introduction of a unique and innovative bridging programme.

This year has been our first full year of Fellows' events and you will see that the diversity of these events and the subject matter have been both challenging and exciting.

# EXECUTIVE DIRECTOR'S REVIEW

#### Conference

The 38th Annual International Nursing and Midwifery Research and Education conference took place in February 2019. Three leading professionals, Professor Linda H. Aiken, Professor Margarete Sandelowski and Dr Judith Shamian were awarded Honorary Fellowships by the Faculty. National and international leaders from research, policy, regulation and practice addressed the conference.

## **Global Initiatives**

I am delighted to announce that Professor Marie Carney was commissioned to undertake archival research for the International Council of Nurses (ICN), as it celebrates its 120th anniversary.
The ICN is the global voice for nursing, and is a federation of 133 national nurses associations representing over twenty million nurses worldwide. Professor Carney attended the ICN congress to launch the commemoration.

In conjunction with the HSE HR department, Mr Kevin Hyland OBE and the ICN, the Faculty collaborated on the development of a booklet supporting nurses to identify and respond to human trafficking. This was also launched at the ICN Congress.

The Faculty has successfully secured collaborative research project funding with the Tuning Project on assessment.

As a Board member of the International Network for Healthcare Workforce Education (INHWE), I was delighted that the Faculty hosted an international conference on interprofessional education here at RCSI. Over 100 interdisciplinary colleagues from 25 countries attended this event.



Candidates for these awards are nominated and ratified by the Board of the Faculty of Nursing & Midwifery, prior to review and ratification by the Surgery and Postgraduate Faculties Board (SPFB), RCSI.

# Fellowship by Examination

is available to registered nurses and midwives with a minimum of five years nursing experience, holding a Masters level qualification in nursing or midwifery or other relevant Masters qualification.

In December, Fellows enjoyed a beautiful Christmas event with artists entertaining the audience with carol singing, hymns and readings, under the leadership of Mr Pat O'Donoghue.











## **April 2019**

Fellows and their guests, enjoyed an "In conversation with" event, as Professor Michael Shannon, Vice Dean, interviewed Ms Catherine Corless, a local historian whose extensive research unearthed records relating to the deaths of 800 babies and infants at the site of the former Mother and Baby Home in Tuam. Catherine's research led to the establishment of the Commission of Investigation into Mother and Baby Homes and the discovery of significant quantities of human remains on that site. Subsequently, Minister Zappone announced approval for a full forensic excavation and exhumation of the babies remains, along with DNA testing, following the legislation bill to be passed to allow this.

During a moving interview, Catherine vividly described her childhood, her life growing up in Tuam, her interest in local history and her comprehensive and detailed research on the Mother and Baby Home in Tuam. The audience was inspired by Catherine's courage, humanity, humility, persistence and strength and equally saddened to hear of the lack of community and institutional support which she received. The question and answer session with Catherine was very engaging and the importance of recognising and courageously managing moral issues was highlighted.

## A Composition of Leadership Principles through Opera

This musical evening will feature Ms Orla Shannon and Professor Michael Shannon, Vice Dean, Faculty of Nursing and Midwifery.

Orla is a lyric coloratura soprano soloist and ensemble singer with wide ranging interests from Baroque to Contemporary repertoire. Her doctoral research on twentieth-century Irish female composers is the recipient of a scholarship awarded by the Irish Research Council. Orla currently studies privately with Professor Ashley Stafford in London and enjoys combining her performative and musicological expertise in a lecturing capacity at DCU.

Professor Michael Shannon has extensive experience in corporate and clinical leadership in Ireland, England and the Middle East. # Guest Lecture Professor Brian Dolan OBE

# **DEAN MARY FRANCES CROWLEY (1906 – 1990)**

SRN, SCM, RGN, OND, Adm. Cert., President, Nurse Tutors Academic Society, founder member and first Dean of the Faculty of Nursing and Midwifery, RCSI.

Born in Wexford, Mary Frances Crowley undertook her professional training in Britain, earning her Registered Nurse Certificate in 1935. She returned to Ireland in 1941 to take up a senior position in Sir Patrick Dun's Hospital. In 1944, she was appointed Assistant Matron of the Royal Victoria Eye and Ear Hospital. Immediately after the war, Crowley travelled to northern France as Matron of the Irish Red Cross Hospital at Saint-Lô (the hospital's storekeeper, interpreter and driver was Samuel Beckett, the future Nobel Laureate). For their work at Saint-Lô, Crowley and her staff were awarded the Médaille de la Reconnaisance française. Crowley founded the Nursing Training School at the Eye and Ear and became Director of Nursing Studies. In 1974, her ambition of many years was realised with the establishment of a Faculty of Nursing at RCSI, the first of its kind in Ireland or Britain.

# **WILLIAM NATHANS**

William Nathans (b. 1981) is a classically trained painter working in the USA and abroad. He began his formal artistic career in New York completing a BFA degree at the School of Visual Arts, NYC and continued for an additional three years in Toronto, Canada at the Academy of Realist Art. Nathans works mainly in oil and dry media, basing his work on studying the subtle range of tones and hues found under atmospheric north light. His work attempts to document the people of his time questioning how the present and the past have shaped them. Notably, Nathans received a commission to paint the official portrait of Cardinal John Foley, Grand Master of the Knights of the Holy Sepulchre which hangs in Vatican City paving his noteworthy achievements in portraiture. Since his relocation from the USA to Ireland in 2013 Nathans has exhibited nationally, including RHA Annual Exhibition (2018). Notably, Nathans's most recent commission is the official portrait of the first woman Chief Justice of Ireland, Justice Susan Denham, which hangs in the Honorable Society of King's Inns.

# 38TH ANNUAL INTERNATIONAL NURSING & MIDWIFERY RESEARCH & EDUCATION **CONFERENCE: AN OVERVIEW**

#### Introduction

The RCSI Faculty of Nursing and Midwifery hosted its 38th Annual International Conference on Wednesday 27th and Thursday 28th February 2019 in the Royal College of Surgeons in Ireland. The Conference continues to attract nurses and midwives from Ireland, Northern Ireland, the United Kingdom, the United States of America and the Middle East. Over 200 delegates enjoyed excellent discussions and interactions at Conference 2019, following the introduction of a more interactive format. Professionally facilitated Panel discussions with global leaders were a new feature this year and stimulated tremendous levels of discussion, dialogue and debate with delegates and panellists.

The Faculty is very proud of its annual flagship event and despite a challenging and competitive conference marketplace, is delighted that many of the delegates return year on year, to hear from renowned global leaders, interact with presenters and share research across a diverse range of clinical, educational and leadership areas. As those of you

who have attended the Conference will know, the Conference's unique welcoming character provides opportunities for nurses, midwives, academics and researchers to share information and ideas, to network, to explore and build on potential collaborations and to influence policy in nursing and midwifery.

The 2019 Conference theme 'The Future of Nursing and Midwifery Practice, Education and Research' was particularly relevant given the industrial dispute - focused on patient safety, safe staffing levels and skill mix - which took place in Ireland in February. Professor Linda Aiken's work in this area globally, and Professor Jonathan Drennan's Irish work on piloting the implementation of safe staffing frameworks was particularly interesting and delegates were keenly aware of how this research is impacting on nursing and midwifery practice at the coalface.

Presentations in the concurrent strands, across a wide variety of areas including Technology Enhanced Learning, Patient, Service User and Clinician Informed Care, Theories and Tools to Underpin Quality in Nursing

Care, Oncology & Palliative Care, Critical and Intensive Care Nursing, Maternity and Child Health and Enhancing Clinical Practices addressed the future of nursing and midwifery. Forty oral presentations were delivered and 55 Poster Presentations were presented.

A Masterclass on "Mixed Methods Research" and a Seminar entitled "Gerontological Nursing in Ireland: Current Perspectives" were concurrently delivered on Friday 1st March 2019.

This year, the Faculty was particularly delighted to launch the DAISY Foundation International Award for Compassion in Nursing at the RCSI. Further detail is presented on this later in the report.

The Faculty appreciates the continued support of Fellows, as it is this that makes the conference such a success.



# **REPORT ON 2019 CONFERENCE**

# **Annual Conference Opening Ceremony, Dinner and Honorary** Fellowship Conferring Ceremony

The Conference was officially opened by Mr Kenneth Mealy, RCSI President following a welcome from Dr Theresa Frawley, Dean, Faculty of Nursing and Midwifery. Mr Kevin Hyland OBE delivered the Opening Address.

Kevin served as the UKs First Commissioner to The Office of the Independent Anti-Slavery Commissioner following the enactment of the Modern Slavery Act 2015. Kevin has a distinguished and an international career in the fight against modern slavery and human trafficking having worked for the Metropolitan Police Service for over 30 years. Kevin also played a central role in the establishment of the Santa Marta Group in 2014, a global alliance of International Law Enforcement Agencies, NGOs and Civil Society organisations working to eradicate human trafficking and modern-day slavery. He also represents Ireland on the Council of Europe's group of experts on Action Against Trafficking of Human Beings (GRETA), who work on combating human trafficking.

Kevin's Opening Address addressed the current challenges of human displacement outlining the myriad reasons such as conflict, oppression, inequality,

climate change and natural disasters, impacting 65 million children, women and men. Human trafficking is a crime which involves someone making a conscious decision to trade in people as a commodity including for forced labour, servitude, sexual exploitation, forced criminality or even for human organs.

Kevin's thought provoking address explored global themes including the current cultural unpopularity of 'inclusion', the 'what's in it for me' culture and the disposable culture which now includes disposable people. In addition, he highlighted the moneymaking motivations which have underpinned slavery throughout history.

# **Honorary Fellowship Conferring** Ceremony

The Faculty was delighted to confer the Faculty's Highest Award, its Honorary Fellowship on three nurses, who have all demonstrated outstanding contributions to the professions of nursing and midwifery and its development throughout their distinguished careers. Professor Linda H. Aiken, Professor Margarete Sandelowski and Dr Judith Shamian were honoured, with Honorary Fellowships in the presence of the Dean, Dr Theresa Frawley, RCSI President Mr Kenneth Mealy, members of the Board and Conference Committee of the Faculty, Past Deans, quests and delegates attending the Annual Dinner.

#### Professor Linda H. Aiken

Professor Linda H. Aiken is the Fagin Leadership Professor in Nursing, Professor of Sociology and Director of the Centre for Health Outcomes and Policy Research at the University of Pennsylvania, USA. Professor Aiken is noted for her pioneering research in the field of nursing care and safe staffing. She developed what is known as the "RN4CAST" project, a study examining how organisational features of hospital care impact on nurse recruitment, retention and patient outcomes. The project is the largest study of its kind, examining nursing care practices in the United States, Europe, Asia, South Africa, Australia and Chile. Dr Catherine O'Neill, Board Member and Citation Reader

stated that "This large-scale study has produced remarkable evidence of the importance of a smaller patient to nurse ratio in improving patient outcomes. Dr Aiken documented that 30-day mortality after common surgical procedures increased by 7% for each additional patient added to a nurse's workload. The study also concluded that patients in hospitals with lower proportions

of nurses with bachelor's degrees have poorer patient outcomes". Speaking on the receipt of her Honorary Fellowship, Dr Aiken said: "I am very proud to receive this Honorary Fellowship from the RCSI Faculty of Nursing and Midwifery. "Nurses are the lifeblood of hospitals the world over, and I am passionate about the safe staffing of nurses in the hospital environment. A healthy

nurse work environment has a range of benefits, not least the significant impact on patient care and safety, as RN4CAST shows. "I am continuing to work with leading educational institutions like RCSI worldwide to find ways to further improve nurse work environments and improve patient care globally".

# **Professor Margarete** Sandelowski

Professor Margarete Sandelowski is the Boshamer Distinguished Professor Emeritus at the University of North Carolina at Chapel Hill, North Carolina, USA. Professor Sandelowski is renowned as a leader in the global research community and widely recognised for her research in the areas of technology, gender and reproductive health.

Ms Mary Godfrey, Board Member and Citation Reader highlighted how "Margarete has been a trailblazer and a crusader in the field of qualitative research, best attributed to her vision, endeavours and expertise, particularly at a time when nursing research in particular and scholarship were in their infancy".

Ms Godfrey also highlighted the prolific outputs by Professor Sandelowski with publications extending over thirty four years. Describing her publications Ms Godfrey stated "Her published books include the award winning (1993) With Child in Mind: Studies of the Personal Encounter with Infertility; two highly praised works in the area of social history include Pain, Pleasure and American Childbirth: From

the Twilight Sleep to the Read Method, 1914-1960 (1984) and Devices and Desires: Gender, Technology and America Nursing (2000), which has been described as one of the "best histories of nursing available today" that makes a valuable contribution to both the history of technology and the history of nursing in the context of the care of patients demonstrating her continuing scholarship".

#### **Dr Judith Shamian**

Dr Judith Shamian is ICN President Emerita, International Council of Nurses (ICN), Geneva, Switzerland. Dr Shamian has an international professional reputation within nursing leadership, research and representation and is one of the best known, highly respected and foremost nursing advocates of her generation.

Dr Mary Boyd, Honorary Secretary and Citation Reader described Dr Shamian's vision for the ICN and how she aspired to maximise the organisation's ability to empower nurses and nursing organisations to influence nursing and health agendas globally. "She achieved this by focusing on health-care solutions. Optimising the use of evidence and expertise is essential to convince

governments and others to improve healthcare policy, by ensuring that nursing speaks with one voice on key issues, and by listening and working with nursing organisations and nurses around the world. ICN's greatest resources are individual nurses and nursing organisations. Together, they made the ICN and its member organisations the best they could be and her Presidency was truly transformational".

Dr Boyd emphasised Dr Shamian's contribution to the development of nursing globally. "Judith has provided consultancy on nursing projects in Israel, China, Hungary, the Barbados, the British Virgin Islands, and the US; one of her major accomplishments was helping Polish nurses establish their national nursing association. Judith has contributed to many expert panels, including several for the World Health Organization: the Expert Advisory Panel on Nursing, the Nursing Advisory Group, and the Global Advisory Committee on Nursing and Midwifery. Dr Shamian served as a Commissioner at the UN High Commission on Health **Employment and Economic** Growth during 2016".

# **OPENING ADDRESS**



**Dr Judith Shamian** 

#### Dr Judith Shamian

Judith is the immediate past President and President Emeritus of the International Council of Nurses (ICN). Dr. Shamian is past president of the Canadian Nurses Association (CNA). She is also a professor at the Lawrence S. Bloomberg Faculty of Nursing at the University of Toronto, and the founding executive director of the Office of Nursing Policy at Health Canada the Canadian Federal Government. Shamian obtained her PhD from Case Western Reserve University, Cleveland, Ohio, her master's in public health from New York University, and her baccalaureate in community nursing from Concordia University in Montreal. Dr. Shamian holds four Honorary Doctorates and recipient of numerous awards including Canada's Most Powerful Women: Top 100 award from the Women's Executive Network.

Dr. Shamian is a strong voice for the role and impact of nurses and nursing can make on global health. Global Health will only be attained by including civil society and professional voices in the planning and implementing of global agendas like UHC, NCDs and others.

In an address entitled "The Future of Nursing and Midwifery Practice, Education and Research: Policy the Missing Link!!!", Dr Shamian addressed how nursing and midwifery have built a cadre of strong highly educated clinicians, educators, researchers and professional leaders in recent decades, with ever-increasing research productivity worldwide and the socialisation of degree prepared nurses and midwifes positively positioning nursing and midwifery for the future. Dr Shamian examined why the nurses' and midwives' voice, impact and influence is shrinking and asked the central question: how is it possible that when we have this growing body of knowledge and large numbers of practitioners, educators and executives, we are unable to see the impact which will improve population and global health? She stated that "My proposition is: unless we learn how to walk the corridors of policy and decision making, enter the door, have a seat at the table and express a voice of influence in policy, financial and other decision making forums, our reality to influence and shape the future will elude us. She called on ever nurse to actively engage within their spheres of influences to make this a reality.

# KEYNOTE ADDRESSES



Professor Linda H Aiken

#### Professor Linda H Aiken

The Claire M. Fagin Leadership Professor of Nursing, Professor of Sociology, Director, Center for Health Outcomes and Policy Research, University of Pennsylvania, Philadelphia, USA.

In a keynote address entitled "Implications of Recent Nursing Outcomes Research for Policy and Practice: An International Perspective", Prof. Aiken highlighted how advances in nursing outcomes research around the world have substantially bolstered the evidence base that should be informing changes in policy, health system redesign, and clinical nursing practice.

She outlined the research findings from studies in Europe, Australia, Latin America, and the US that are applicable worldwide in improving patient outcomes, enhancing the recruitment and retention of nurses, and enhancing the value of investments in healthcare. She also discussed the potential impact from the introduction of mandated hospital nurse staffing in Queensland, Australia. Her presentation focused on the evidence which impacts on nurse staffing, skill mix, nurse educational qualifications, and the quality of work environments on hospital patient outcomes and health system financial outcomes. She also briefly addressed the outcomes of advanced practice nursing in some jurisdictions.

## Professor Jonathan Drennan

The Faculty was delighted to welcome its Fellow, Professor Jonathan Drennan who explored "The Impact of an Intentional Change to Nursing Staffing on Patient, Nurse and Organisational Outcomes: Results from a Programme of Research into Safe Nurse Staffing in Ireland" in his keynote address.

Prof. Drennan's presentation discussed the impact that planned changes to nurse staffing and skill-mix have on patient, nurse, and organisational outcomes in hospitals in Ireland. These changes were implemented in number of pilot hospital sites as part of the recommendations in the Department of Health (2018) published document entitled a Framework for Safe Nurse Staffing and Skill Mix in Ireland. In this report a number of recommendations were made to ensure that the staffing of hospitals was safe and effective; that is to ensure the right number of nurses are in the right place at the right time and with the right skills to deliver care. However, it has been highlighted that there are several design limitations in studies that explore the relationship between nurse staffing and patient, nurse and organisational outcomes; not least that the vast majority of research in this area emanates from studies that are predominantly observational in design. To counter these limitations, the research discussed in his paper followed several recommendations that have been made on enhancing methodological approaches to measure the association between nurse staffing and outcomes. These approaches included: before and after and longitudinal study designs, inclusion of the unit of analysis at ward rather than hospital level, repeated measures over time and, the collection of staffing levels for each shift rather than nurse self-reports. The design allowed his team to measure the temporal precedence of events; that is the outcomes observed followed the intervention (i.e., changes to staffing). The paper concluded with the results from the research to date in Ireland and the impact that changes in nurse staffing are having on patient, nurse and organisational outcomes.

#### Professor Margarete Sandelowski

In her keynote address, entitled "Nursing Scholarship for the Future", Prof. Sandelowski explored how the scholarship demands on academic nursing have changed dramatically over the last thirty years particularly the increasing corporatization (Darbyshire, 2015) of higher education, along with the consumeroriented "knowledge economy" (Girot, 2010) and its associated emphasis on functionality and efficiency.

She highlighted the need for initiatives such as multidisciplinary research teams, vibrant research environments, the enhancement of scholarship at all levels of nursing education and the need for accelerated/integrated BSN/PhD programmes. She also highlighted the need for training in 'Grantsmanship', and innovation approaches to the teaching of research across all nursing and midwifery, advocating the abandonment of the quantitative/qualitative binary. Prof. Sandelowski spoke passionately about the need for mentorship programmes in research and scholarship development for junior faculty and she stressed the urgency in building nursing confidence in the right to claim expertise, stating that it is "impossible to draw clean lines around disciplines".

#### Panel Discussion

Dr Judith Shamian, Professor Linda Aiken and Professor Jonathan Drennan were joined by global and national leaders for a lively panel discussion exploring areas such as the implementation of the safe staffing frameworks, skill mix and the future of nursing and midwifery. The Panel was chaired by RTE Journalist and Current Affairs presenter, Ms Miriam O'Callaghan.

Prof. Ingalill Rahm Hallberg Research Informed Practise; Pragmatic, Complex or Comparative Effectiveness Interventions

#### Prof. Ingalill Rahm Hallberg

Professor Emerita Ingalill Rahm Hallberg (RN, PhD, FEANS, FAAN) is a Professor in healthcare science at Lund University, Sweden. She is a registered nurse in mental health and a Fellow of the American Academy of Nursing and of the European Academy of Nursing Science, an organisation she participated in initiating and later on became the president of for several years. During that time she, together with the Board, implemented complex interventions as a curriculum for the three year summer school for PhD students in Europe and together with Professor D.A. Richards edited the handbook of Complex Interventions in Health.

Nationally she built up and managed a large interdisciplinary institute for health sciences. She became honorary member of the Swedish Medical Society for her contribution to knowledge building useful for practice. She has been the prodean of the medical faculty as well as the assistant and pro-vice chancellor of Lund University. Internationally, she is well known in particular for her research on ageing, healthcare and social service to older people and also for her engagement in furthering nursing research from discovery to evaluation. It is within this area she has been the main supervisor of 29 PhD students and in addition co-supervised several PhD students. Currently she is working together with clinicians and experimental researchers to understand the molecular fingerprints of psychological resilience in women with breast cancer. This research was initiated by Prof. Hallberg in the attempt to close the gap between body and mind and better understand that interaction and thereby improve treatment.



Prof. Alessandro Stievano Scholarship in Europe: The Italian Experience

#### Prof. Alessandro Stievano

Alessandro Stievano (PhD, MSN, RN, FAAN, FFNMRCSI), is currently Associate Director for Nursing and Health Policy at the International Council of Nurses. Additionally, he is also research coordinator of the Centre of Excellence for Nursing Scholarship of Opi Rome - Italy. The Centre is a novel project to designate substantial administrative and funding support for advancing nursing education, clinical practice, research development and research training in Italy.

Prof. Stievano received a Master's degree in Education (Rome Three University - Rome -Italy) and a Master's degree in Sociology from Alma Mater University of Bologna - Italy. He is author of multiple peer-reviewed publications on a national and international level. His main professional interests are connected to ethics and transcultural movements of health professionals in the globalised society. Prof. Stievano holds Editorial Board positions on journals such as Nursing Ethics and Nurse Education in Practice. He is the President of the Italian Transcultural Nursing Association. He has received an Honorary Fellow ad Eundem from the Faculty of Nursing & Midwifery, RCSI in 2016.

## **FACULTY DEVELOPMENTS**

#### **Aptitude Test for Overseas Nurses**

Between July 2018 and June 2019, 793 applicants from 33 countries completed the RCSI FNM Aptitude Test for Overseas Nurses.

To work as a nurse in the Republic of Ireland, a person must be on the active Register of the Nursing and Midwifery Board of Ireland (NMBI). A person who trained overseas must undergo a full regulatory assessment by the NMBI. Following such an assessment, a person may be required to successfully complete a compensation measure as a pre-requisite to registration. One such measure is the RCSI FNM Aptitude Test for Overseas Nurses. In 2014, Professor Thomas Kearns, Executive Director of the FNM, scoped the concept of an Aptitude Test and conducted an in-depth national consultation and research study that informed its development. The first test took place in December 2015.

It is the single and currently the preferred, national Nursing and Midwifery Board of Ireland (NMBI) approved and monitored assessment for overseas nurses (EU and non-EU) wishing to register and work in Ireland.

The Aptitude Test is based on two assessment methods: a theoretical component and a

practical component. The theory component consists of a supervised online assessment of professional knowledge and understanding. A method of assessment known as multiple-choice questions is used. A methodology known as Objective Structured Clinical Examination (OSCE) is used for the practical component. The OSCE assessors are experienced nurses, from a wide range of healthcare facilities, who hold a post-graduate qualification and have been trained by RCSI as OSCE assessors. Each applicant is assessed by 28 assessors in 14 independent groups of two.

Promotion of the Aptitude Test continued both nationally and internationally, with several seminars held throughout India.

The Aptitude Test underwent a full quality review by the RCSI Quality Enhancement Office. The outcome of the audit was very positive and findings concluded that a) there is a positive focus on the quality of the applicant experience; b) the test is well designed and delivered in a professional and calm manner using a well-appointed and suitable venue; and c) the provision of information regarding all aspects of the test via the FNM website is exemplary. The on-going work on the recommendations continues to add strength to the test.

The Aptitude Test was submitted for the RCSI Education Innovation Award 2019. From a field of 33 submissions, it was shortlisted in the top seven for presentation at the International Education Forum.

The Faculty has been requested by HSE HR to scope the development of a test for mental health nurses leading to registration as an RPN.

## **CPD Programme Development and Delivery**

The Faculty of Nursing & Midwifery has a long and proud history in the delivery of education. Work continues on our journey to become the leading provider of professional education and training, for nurses, midwives and professionals working in the healthcare arena, in Ireland.

To this end, Dr Edward Naessens, is specifically tasked with preparing for the roll out of online and blended CPD. He is investigating principles of effective pedagogy and approaches to professional life-long learning, including solutions currently available within RCSI, and beyond in the Irish and European professional settings. Interacting with learning specialists within the college and beyond, he is building insights for the development of effectively-designed online courses that meet the needs of healthcare professionals. He has engaged with stakeholders to produce a survey for healthcare professionals which has yielded valuable insights into the digital skills and openness to online and blended learning approaches to CPD.

Among other avenues and solutions he is exploring the potential benefits of emerging medical and educational technology including rapid course development systems using AI, AR, VR, and other evolving applications that enhance learning interaction and engagement built to facilitate busy professional lives. He is in preproduction of a pilot version of an

online/blended CPD course. The main aim of the pilot project is to identify the best ways to deploy a rapid development process that can generate online and blended CPD courses that are engaging, interactive, cost-effective and responsive to the learning needs of our clients.

Dr Mary O'Neill facilitated an open forum discussion on the future of CPD where the group debated and discussed the emerging trends in CPD and the enabling and challenging factors for CPD within nursing and midwifery.

#### Launch of the DAISY Foundation International Award for Compassion in Nursing at the RCSI

In February 2019, the Faculty was particularly delighted to launch the **DAISY Foundation International** Award for Compassion in Nursing at the RCSI. The DAISY Foundation is an international award foundation, based in the US. It recognises and rewards excellence in compassion in nursing worldwide. DAISY is an acronym for Diseases Attacking the Immune System. Mr and Mrs Mark and Bonnie Barnes from the DAISY Foundation delivered a very moving presentation, where they presented the genesis of their foundation following the untimely and sudden death of their son Patrick J. Barnes twenty years ago at the age of thirty three.

The DAISY Award is now celebrated in over 3,400 healthcare facilities and

colleges of nursing in 19 countries. Over 100,000 nurses have been honoured, having been nominated by their patients, patient families, and colleagues. Each nomination (of which there have been well over 1 million) tells the story of extraordinary compassion and care provided to a patient. The DAISY Award provides healthcare leaders the means to highlight all the "right" going on in their organisations, providing great role-modelling opportunities, and a way to make tangible the organisations' mission and values. The result is a programme that helps drive organisational culture, inspire and motivate extraordinary nursing, nourish teamwork, enhance nurse engagement, promote the professional image of nursing, and

offset compassion fatigue with compassion satisfaction.

The Foundation's work is supported by numerous professional organisations, including, the International Council of Nurses, American Organization of Nurse Executives, the American Nurses Credentialing Center (a division of the American Nurses Association), the American Association of Critical-Care Nurses, the American Association of Colleges of Nursing, the National League for Nursing, the Institute for Healthcare Improvement, and Sigma Theta Tau International, the Honor Society for Nursing.

#### **RCSI Hospital Group Nursing Now Campaign Group**

The Faculty in partnership with the RCSI Hospital group launched the RCSI Hospital Group Nursing Now Campaign Group in June 2019. This launch followed on from the national launch of the Nursing Now Campaign in April.

Nursing Now is a global campaign that was launched in February 2018 and is supported by the World Health Organization (WHO) and the International Council of Nurses (ICN).

Nursing Now aims to improve health globally by raising the profile and status of nurses worldwide, influencing policymakers and supporting nurses themselves to lead, learn and build a global movement. The campaign launched by patron Her Royal Highness The Duchess of Cambridge in early 2018 recognises that nurses are at the heart of countries' efforts to provide health for all. As one of the most trusted professions, nurses provide effective and quality care for people of all ages and are central in addressing the increasing burden of non-communicable diseases such as cancer, heart disease, obesity and mental health.

The campaign is the brain child of Lord Nigel Crisp and has evolved from the Triple Impact of Nursing Report (2016) in the UK. This report acknowledged and articulated the

unique contribution of nurses and the many roles of nurses in the delivery of healthcare. Significantly, this report underlined the important role of nurses in the provision and management of care and treatment, the central role of nurses in the delivery of public health services and health promotion and their role in the prevention and management of infection. It also focused on the humanity of nurses and their skills in developing and building trusting partnerships with their patients, clients and service users.

The report contended that the strengthening of nursing would result in a triple impact, on a number of Sustainable Development Goals namely improving health, promoting gender equality - as the vast majority of nurses are women - and supporting economic growth. The report recognises that nurses are at the heart of most health teams, playing a crucial role in health promotion, disease prevention and treatment. As the health professionals who are closest to the community they have a particular role in developing new models of community based care and supporting local efforts to promote health and prevent disease.

The Nursing Now campaign calls on politicians, governments and nonnursing health leaders to profoundly change the perceptions and roles of nurses and midwives to ensure the optimisation of their skill-set. Nursing Now seeks to empower nurses to take their place at the heart of tackling 21st century health challenges and maximise their contribution to achieving Universal Health Coverage.

The campaign focuses on five core areas: ensuring that nurses and midwives have a more prominent voice in health policy-making; encouraging greater investment in the nursing workforce; recruiting more nurses into leadership positions; conducting research that helps determine where nurses can have the greatest impact; and sharing of best nursing practices.

The Nursing Now campaign is Co-Chaired by Lord Nigel Crisp, Co-Chair, UK All Party Parliamentary Group on Global Health; Baroness Mary Watkins, Nurse Academic and Crossbench Member, UK House of Lords and Professor Sheila Tlou, Co-Chair of the Global HIV Prevention Coalition. Interestingly, one of the Faculty's Honorary Fellows, HRH Princess Muna Al Hussein of Jordan, champions Nursing Now in her role as WHO patron of nursing and midwifery in the Eastern Mediterranean Region. Nursing Now is headquartered in London and is being run as a

programme of the Burdett Trust for Nursing, an independent charitable trust based in the UK. The Campaign Board includes individuals from sixteen countries alongside representatives from the International Council of Nurses and the Burdett Trust for Nursing as well as the Director of WHO's Health Workforce Department, Dr Jim Campbell.

To date, Nursing Now has been launched in 103 countries. The campaign will run to the end of 2020, the 200th anniversary of Florence Nightingale's birth and a year when nurses will be celebrated worldwide.























#### Academic Excellence, School of Nursing and Midwifery, RCSI

Dr Theresa Frawley, Dean presented the Florence Nightingale Medal and the Mary Frances Crowley Medal to post graduate students at the conferring ceremony in the National Convention Centre, Dublin on 19th November 2018. Students of the School of Nursing and Midwifery, RCSI who achieved the highest overall grades in the BSc and MSc programmes were acknowledged for their achievements.



The Florence Nightingale Medal was awarded to Ms Sarah Blanchfield on completion of her BSc Nursing Management – Level 8.

The Mary Frances Crowley Medal, was awarded to Mr Damien McCroy on completion of his MSc Nursing Advanced Leadership – Level 9. Damien was also the Valedictorian.

## RESEARCH DEVELOPMENTS

#### **European Centre of Excellence** (CoE) for Continuing Professional **Development (CPD) in Nursing**

The aim of this Centre is to establish a Pan European network of researchers, clinicians, regulators, professional bodies to advance the science of Continuing Professional Development (CPD) through research and foster knowledge exchange that will promote best practice in CPD that can be translated across Europe.

The Centre will support research in the field of CPD in nursing and midwifery, support collaborative research projects with European and national partners, build networks with academic experts to boost CPD research, contribute to the development and strengthening of national CPD systems and exchange information on best practice for CPD. Currently, there are approximately 40 members from the following 20 countries: Albania, Belgium, Croatia, Faroe Islands, Finland, France, Germany, Greece, Hungary, Ireland, Italy, Lithuania, Malta, Netherlands, Portugal, Romania, Slovenia, Spain, UK, and USA. Members of the Centre are from a variety of backgrounds including academia, regulation and professional associations.

Dr Cathy Fitzgerald was engaged by the Faculty of Nursing in April 2019 to further develop the centre. To assist in the development of the Centre a Steering Group was organised. Membership of the Steering Group of the Centre has collective responsibility for the initial planning and development of the CoE.

The role of steering group is to:

- Define scope of work of the Centre;
- Develop a governance model;
- Develop a process for setting a research agenda;
- Ensure the strategies agreed upon by members are implemented;
- Identify potential research streams.

Two meetings have taken place in June and September 2019. The Steering Group have developed a mind map for CPD (Figure 1) and have decided on an agreed definition for CPD for the centre; "systematic maintenance, improvement and continuous acquisition and/ or reinforcement of the life-long knowledge, skills and competences of health professionals. It is pivotal to meeting patient, health service delivery and individual

professional learning needs. The term acknowledges not only the wide ranging competences needed to practice high quality care delivery but also the multi-disciplinary context of patient care" (EAHC1, 2013, p. 6)

They also developed a vision, mission and values document along with a framework design (Figure 2) a visual structure that will help organise the information and ideas for the centre to work on its development more effectively.

The official launch of the centre will take place in February 2020 to coincide with the 39th Annual International Nursing & Midwifery Research and Education Conference at RCSI.



## ARCHIVAL RESEARCH FOR INTERNATIONAL **COUNCIL OF NURSES (ICN)**

Professor Marie Carney was invited by the International Council of Nurses (ICN) to undertake archival research for the 120th anniversary of the organisation. This work was subsequently presented as an interactive exhibition detailing the 120-year history of the ICN and was launched at its Congress in Singapore, where more than 5,000 nurses gathered from across the globe.

Each exhibition panel represents the history of ICN by decade (1999-2019) and Professor Carney used history, text and photographs to complete this research. ICN also produced an App to accompany the panels in the exhibition. The App contained research narrative and photos obtained from the archives. Professor Carney represented the Faculty in answering historical questions from delegates during the opening of the Exhibition.

#### **Human Trafficking Pamphlet**

Working in collaboration with Mr Kevin Hyland OBE & member of the Council of Europe Independent Group of Experts for Trafficking and former Independent Anti-Slavery Commissioner for the UK, the International Council of Nurses and HSE HR, collaborated on the development of a pamphlet to address the signs of and responses by nurses to suspected human trafficking.

During the launch of the pamphlet at the ICN Congress in Singapore, Mr Howard Catton, Chief Executive, ICN highlighted the duty of nurses to protect those in danger along with the importance of understanding how to recognise and report suspected incidents. He also stressed how the positioning of and the role of nurses in frontline service delivery, particularly, primary health care settings, could greatly influence and contribute to the early

detection of physical and/or psychological issues in suspected human trafficking victims and be able to appropriately respond to the individual's needs.

Ms Catherine Clune Mulvaney secured an Erasmus Training Grant funding to visit colleagues at the Centre of Excellence for Nursing Scholarship (CoE), Rome, Italy as part of an Erasmus Mobility Agreement in September 2018. The Centre of Excellence is a project of the OPI Nursing College of Rome.

The purpose of this three-day visit was to learn how the CoE developed and evolved its approach to nursing scholarship and in particular to discuss the critical success factors to the Centre's approach nationally. The visit also provided an opportunity to explore potential collaborations for the future, between the Faculty and the CoE.

Catherine's Erasmus report on the visit is below.

"...I was privileged to spend time at the OPI Centre of Excellence for Nursing Scholarship and meet with colleagues. In particular, I was delighted to spend time with the Centre's Director, Professor Gennaro Rocco and Professor Alessandro Stievano, the Centre's Research Coordinator, who is also the ICN Associate Director for Nursing and Health Policy. During the visit, I also had the privilege of meeting with Ms Ausilia Pulimeno, OPI President.

Following a very warm welcome from Professors Rocco and

Stievano, I spent three wonderful days learning about their work, and the significant role the Centre has played in the evolution and professionalisation of nursing in Italy. As I heard detailed information about the purpose of the centre, its objectives, its work and the significant published research output, I was struck by the similarities with the RCSI Faculty of Nursing and Midwifery, and the important elements we shared.

Firstly, the vision of the founders, who for me are very inspiring people and whose actions have shaped the development of professional nursing and midwifery. In Ireland, Ms Mary Frances Crowley, the founding Dean, together with the Founding Fellows, recognised the need for, and importance of further education for nurses after qualification. They understood how new and advanced knowledge could enhance the understanding and the abilities of the nurse to provide skilful care. Since its establishment in 1974, the Faculty has provided opportunities for nurses to avail of modules in areas such as microbiology, pharmacology and management and this was very significant in Ireland at that time.

In Italy, Professors Rocco and Stievano together with colleagues saw the need for the establishment of a centre to advance professional

nursing in Italy. In 2009, the Centre was established and Boyer's Model of Scholarship (1990) was used as a theoretical foundation to the centre's work, with Education, Research, Research Training and Clinical Practice adopted as the pillars to develop scholarship in Italy. While each pillar has its own aims, there is interconnectedness between all four. Similar to the Faculty's philosophy, the Centre's ultimate aim is "to fathom the world of nursing research to improve the quality of care provided to the public and the public's perception of the nursing profession". As Professors Rocco and Stievano discussed some of the findings from the Centre's extensive research profile, I was left in no doubt that Italian patients are benefitting from this work.

Secondly, I was struck by the collaborative, partnership approach used within the Centre in its approach, and its work resonated very deeply with me. As Professors Rocco and Stievano spoke about how they developed their research and mentioned all those who they work with - clinical nurses, researchers, students, government, the public, nurse leaders, regulators and other allied health professionals - I appreciated the importance of ensuring how the work of the Centre reflects the needs of the clinical area. Indeed, this approach is very evident in the

Faculty, to this day and we have a long and proud tradition in the development and delivery of programmes to meet the needs of practising nurses and midwives, and the service. As healthcare continues to evolve, service needs change and continuing professional development and lifelong learning become critical to the delivery of safe patient care.

I had the privilege of seeing this collaboration as I attended a meeting with Dr Silvia Marcadelli and a new PhD student, as they worked to refine a research proposal, with Professor Stievano. The proposed research focused on the exploration of community nurses in Italy. I was able to share the Irish experience and talk about the role of the Public Health Nurse in Ireland.

Finally, I was struck by the Centre's active agenda in disseminating research findings from its extensive research portfolio. Findings are disseminated with registrants through a diverse range of mediums, including Masterclasses, Conferences and their journal, "Infermiere Oggi" which is printed and delivered to 35,000 nurses and midwives. I was delighted to read through the scientific programmes from a number of their conferences, and see the diverse range of research being undertaken through the Centre. Nurses also have access to the Centre's library, where in comfortable surroundings, one can browse the significant

collection of journals and network with colleagues. Nurses have access to three databases- CINAHL, Ovid and the Cochrane Library- and this accessibility greatly enhances nursing engagement with up-to-date research. The Centre has also been accredited as a collaborator in the Joanna Briggs Collaboration.

The Centre also provides over forty clinically focused Continuing Professional Development (CPD) programmes annually. The programmes are facilitated by experts in clinical practice. It was interesting to learn that the Centre favours face-to-face, classroom based teaching, with some blended learning available. The Centre has found that student learning and experience has been enhanced from meeting colleagues in the class, and this has also helped individual nurses and midwives to develop networks, in their professional practice.

One of the aims of this agreement, was to promote the Faculty's Annual International Nursing and Midwifery Research and Education Conference, whose theme for 2019 is, "The Future of Nursing and Midwifery Practice, Education and Research". We explored the potential for collaboration on a seminar focused on scholarship during my trip and I am delighted to announce that this seminar will take place on Thursday 28th February 2019 in the Faculty of Nursing and Midwifery, RCSI. A working title of "Nursing Scholarship in Europe- The Italian Experience",

has been agreed, and I anticipate that this collaboration, will be the first of many, following this Erasmus opportunity.

I would like to acknowledge Professor Gennaro Rocco, President, OPI Centre of Excellence for Nursing Scholarship and Professor Alessandro Stievano, Research Coordinator Centre of Excellence for Nursing Scholarship OPI Centre Rome, Italy and thank them for their time, their expertise and their willingness to share information. It was a wonderful opportunity to discuss and explore how our organisations could collaborate in the future and I am delighted that the Seminar on Scholarship, in February 2019, will provide a platform for learnings from the Italian approach to be shared with nursing and midwifery colleagues from around the globe.

Finally, I would like to thank my RCSI colleagues, Professor Marc Devocelle, Erasmus Officer and Ms Mary Plunkett, Erasmus Administrator for their time and expertise with the application process. I would also like to acknowledge the support of the Board of the Faculty of Nursing and Midwifery, in particular, Dr Theresa Frawley, Dean".

#### Global R.E.S.P.E.C.T. Project

The Faculty is collaborating with Professor D'Arcy Gaisser, and colleagues Dr Connie Lawrence and Ms Jennifer Smalls, at the Department of Nursing, The College at Brockport on an international project - Global R.E.S.P.E.C.T. of Incivility. R.E.S.P.E.C.T is an acronym for Research for Establishing Supportive and Professional Education for Cross-Cultural Transformation.

Given the documented problems globally with bullying and incivility, the Faculty believe this project will have implications for staff wellbeing, staff retention and turnover, and ultimately the delivery of safe, quality care.

The Faculty will participate in the study as a Co-PI for the Pilot and Phase 1 of the study. A grant application was submitted to Sigma Theta Tau International.

## Psychiatric Nurses Association of Ireland

The collaboration with the Psychiatric Nurses Association of Ireland (PNA) continues to grow and develop under the leadership of Ms Aisling Culhane, Research and Development Advisor and Ms Catherine Clune Mulvaney, Operations and Education Manager, Faculty of Nursing and Midwifery.

The range of programme offerings has increased and a new clinically focused programme of particular importance entitled "Physical Health Care for Mental Health Professionals; Screening for, Preventing and Intervening in Chronic Diseases", has been developed in response to service need. Work continues on new programme development in the management of sexual assault and violence for psychiatric nurses in the community focusing on interagency collaboration.

clinicians assist participants with the application of complex theoretical concepts to the real world of patient care. The programmes are facilitated in an interactive manner, using


discussion, group work, questioning and case studies to create an interactive classroom experience for the participants. Programme evaluation remains positive.
